

# Need for Criminal Investigation

Systematic Collection of Evidence – Enables proper gathering and scientific examination of evidence to reconstruct the sequence of events.

Identification of Crucial Elements – Helps determine what occurred, who is responsible, and the method used to commit the crime.

Crime Resolution and Prosecution – Accurate identification and preservation of physical and digital evidence are vital for solving crimes and securing convictions.

Role of Law Enforcement – Successful prosecution largely depends on the quality and credibility of evidence uncovered through effective investigation.

Legal Competence – Sound investigative knowledge is indispensable for legal professionals dealing with criminal matters.

Wide Relevance – Basic investigative skills are essential for all stakeholders within the criminal justice system.

## Eligibility

Open to full-time undergraduate and postgraduate students from Law discipline.

Each team must comprise three members.

There is no limit on the number of teams participating from a single institution.

## Competition Format & Rules

**Briefing and Orientation:** Participants will be given a preliminary briefing, including case background and essential facts, prior to entering the crime scene.

### Official language

The official language of the competition shall be English. All stages of the competition, including proceedings and report submissions, must be conducted and submitted in English only.



Participants will be allotted 20 minutes to carefully observe and document their findings.

Basic stationery such as pen and notepad will be provided; any additional materials must be brought by the participants.

Use of mobile phones is strictly prohibited.

Participants are not permitted to touch, alter or move any evidence at the scene.

### **Report Preparation (30 Minutes):**

The report must include:

- Background details of the crime.
- Crime scene sketches (minimum 2, maximum 5).
- Identification and classification of evidence along with its legal relevance.
- A reasoned hypothesis identifying the suspect(s).
- A conclusive, opinion-based reconstruction of the incident.
- Forensic analysis and any additional relevant observations.

## Judging Criteria

### DISCLAIMER

Reports will be assessed by forensic and legal experts on the basis of accuracy, logical reasoning, and overall presentation.

Evaluation will focus on participants' observational and interpretational skills.

Assessment of evidence handling and problem-solving abilities.

Emphasis on effective note-taking, precise sketching, and analytical thinking.

Quality, coherence, and clarity of report writing will be considered.

Ability to correctly identify the cause of the crime, the suspect, and the modus operandi.


